The monthly meeting of the Abbott Township Board of Supervisors was held on Monday July 1, 2024 at 7:00pm at the township building.

1. Present at the meeting were: Lee Gardner, Jared Lazorchak, Beth Kreiser, Randy Culp, Pat Shellhorn, Brian Schultz, Ken "Sharky" Loiacono, and Cory Shifflett
2. Meeting was called to order by Chairman Jared Lazorchak at 7:01pm.
3. The Pledge of Allegiance was recited.
4. Jared made a motion to approve the meeting minutes for the last meeting that was held on June 3, 2024. Randy seconded; AIF motion carried.
