Fire Company received an emergency permit to replace/repair the sluice pipe by the fire company rental house that was damaged by the flood in August, the township will be working with the Fire Company to get this completed.

Randy attended a meeting with Gale Hose EMS regarding improvements to their services.

Supervisors met with Potter County Conservation District/ GIS Department at Ole Bull State Park to discuss new initiatives happening.

The Township ordered 12 loads of 2RC stone on August 28, 2024 to be stockpiled and used to repair and replace roads that had damage from the flood. Per Darin Stover, our Penndot, rep we were able to order this stone with out including it in our totals for bidding requirements due to the County being in a state of emergency as declared by the state.

Fall clean up will be combined with West Branch Township this year and will take place at their facility located on Pigeon Hill Rd on Saturday October 5, 2024 from 8am -. Abbott Township property owners will be asked for ID and a property address prior to disposal.
